Public Policy & Legislative

Committee Chair Mayes shared information about an upcoming trip to Juneau, Alaska in March for the Alaska Deaf Council to meet with state legislators and agencies. The plan is for ADC to have at least eight meetings while in Juneau to secure additional funding for the Deaf Navigator Program and build a coalition of support for the Deaf Children Bill of Rights. There will be at least 7 people going on this trip including 4 Deaf leaders, 1 or 2 parents.

Chairperson Mayes is still working out the logistics of this trip with several stakeholders and will work on securing funding from different sources to cover the accommodation and airfare tickets for the trip to Juneau.

Chairperson Mayes also shared that he met with a group of parents in Eagle River to discuss the Bill of Rights and the results of the Town Hall. Chairperson Baldwin also explained that parents had varied experiences with ILP and some are very opinionated about what is best for their children.

- Board Expectations Referred to ad hoc Committee
 - Vice President Di Giovanni motioned for the ADC to adopt a Board Policy Manual that would include Meeting Etiquette, Governance, and how to administer the Zero Tolerance Policy. Member at Large Gordon seconded the motion and upon discussion it was determined that the motion needed to be referred to an ad hoc Committee compromising the entire Board for the next 30 days to draft the manual before the next Board meeting in December. The motion to refer to an ad hoc committee was passed unanimously.
- Setting The Budget for 2025 Referred to the Budget & Finance Committee President Jensen suggested that the Board of Directors go ahead and set the Budget for 2025 to cover Interpreting Grants, Scuba Diving Workshops, Events, and Etc. Vice President Di Giovanni motioned to refer this to the Budget & Finance Committee as it is their responsibility to draft a Budget for the Board to approve and Member at Large Schramski seconded this motion. The Board voted unanimously to refer this to the Budget & Finance Committee for review.
- Sponsorship Letters for AANO & ADC Tabled to Next Meeting President Jensen shared that someone should make a motion for the ADC to have templates for Sponsorship letters. Vice President Di Giovanni mentioned that a motion wasn't necessary at the time and that we could table this topic to the next meeting to give the Board an opportunity to review the template. Member at Large Gordon seconded this, and the motion was tabled unanimously.

New Business

Reimbursement for Vice President Di Giovanni – PASSED
Treasurer Veatch motioned for the ADC to reimburse Vice President Di Giovanni
\$153.97 for three months of billing for a Zoom premium subscription of \$14.99 each
month and \$109 for the usage of the Birch Room at the BP Energy Center for the
ADC Town Hall in January. Member at Large Gordon seconded the motion, and the
Board unanimously approved the motion.
